

Terms and Conditions

1. Overview

1.1 The Wharton/PRI Executive Certificate: Impact, Value and the Materiality of Sustainability course consists of a 9-week online programme scheduled to take place from 12 February 2026 to 9 April 2026, hosted live online with asynchronous work (“the **Course**”).

1.2 The Course is delivered jointly by Wharton Business School (“**Wharton**”) and PRI Academy (“**PRI**”), using Wharton Business School’s online WAVE platform.

1.3 In these terms and conditions, “Registrant” means any individual who has registered for the Course. “PRI” means PRI Academy, the trading name for PRI Enterprises, a company registered in England and Wales under registered number 07207947 having its registered address at 1st Floor 20 Wood Street, London, EC2V 7AF, United Kingdom. “Wharton” means the Aresty Institute of Executive Education at The Wharton School, University of Pennsylvania, South 38th Street, Philadelphia, PA, United States of America.

1.4 PRI and Wharton shall use reasonable endeavors to adhere to the advertised Course outline but may change the format, speakers, content, online platform hosting or any other aspect of the Course at any time and for any reason without liability.

2. Registration and fees

2.1 In order to apply to the Course, you must complete the registration form online.

2.2 By registering for the Course, you/your organisation agree(s) to be bound by

2.2(a) these Terms and Conditions; and

2.2(b) the PRI Academy Terms and Conditions available online on the PRI Academy website at the following address www.priacademy.org/terms-and-conditions/, which comprise the Website Terms of Use, Part A: General Terms, Part B: Additional Terms, and the Terms of Sale for Individuals.

2.3 In the event of any conflict between the above two sets of terms and conditions, these Terms and Conditions shall prevail.

2.4 PRI or Wharton reserve the right to refuse a registration for enrolment in the Course at their discretion.

2.4 Registrations will be available on a first-come, first-served basis. A minimum of 20 and a maximum of 96 learners can join the Course. PRI will inform you if your application has been successful. As stated in the PRI Academy Terms and Conditions referenced at clause 2.2(b), PRI reserves the right to cancel or postpone the Course at their discretion, including in the event of insufficient numbers applying for the Course.

2.5 The Course fee is \$7,000 exclusive of any applicable sales tax (“**the Course Fee**”). All fees are payable in USD. Your acceptance of these Terms and Conditions confirms your agreement to pay the Course Fee on demand by PRI promptly following notification of your successful application in accordance with clause 2.4. If you have any queries about payment, please email academysupport@unpri.org.

2.6 If you have not paid the Course Fee by the date specified on your invoice, you will not receive access to the Course.

2.7 Registrant places are for your personal use only and may not be shared between multiple attendees during the Course. A breach or suspected breach of this clause shall give PRI and Wharton the right to revoke access to the Course and any Course resources or platforms with immediate effect and no refund will be provided.

3. Cancellations and substitutions

3.1 You may cancel your enrolment within 14 days of being notified by PRI that you have been accepted on the Course, in accordance with clause 2.4 above. To cancel please email priacademy@unpri.org. Cancellations received within this timeframe are eligible for a full refund of the Course Fee from PRI, less an administration fee of 150GBP.

3.2 Cancellations received by PRI after the deadline in clause 3.1 above are non-refundable.

3.3 PRI may offer substitutions to the Course at its discretion. There is no right to a substitution, but we will endeavour to accommodate any reasonable requests.

3.4 No refund is available to no-show Registrants.

5. Conduct

5.1 Where your conduct during the Course is unacceptable (in the reasonable opinion of PRI), we reserve the right to revoke access to the Course and all associated resources immediately and no refund of the Course Fee will be made.

6. Participant Information

6.1 Registrants will be sent participant information by email at least five days prior to the first welcome session.

6.2 Any Registrant not receiving the participant information should contact PRI at priacademy@unpri.org.

7. Data Protection and compliance

7.1 In order for us to fulfil this contract, your personal data will be transferred to Wharton (which may include their approved suppliers) in accordance with the PRI's [Privacy Policy](#), as set out above. Please note that this will include sending your data outside of the UK, including to the US. Where we are required to carry out an international transfer of your data, we will ensure that this is done in compliance with all applicable data protection laws. Please note that PRI will provide Wharton with each Registrant's full name, country of residence, and job title/company so that Wharton can screen each Registrant against any "restricted party" list maintained and published by any arm or department of the US government (including the Department of Commerce, Department of State, and Department of Treasury). Wharton and/or PRI may prohibit Registrant from participating in the Course where they fail this screening process or where the Registrant is reasonably believed to be subject to a relevant geographic or thematic sanction.
